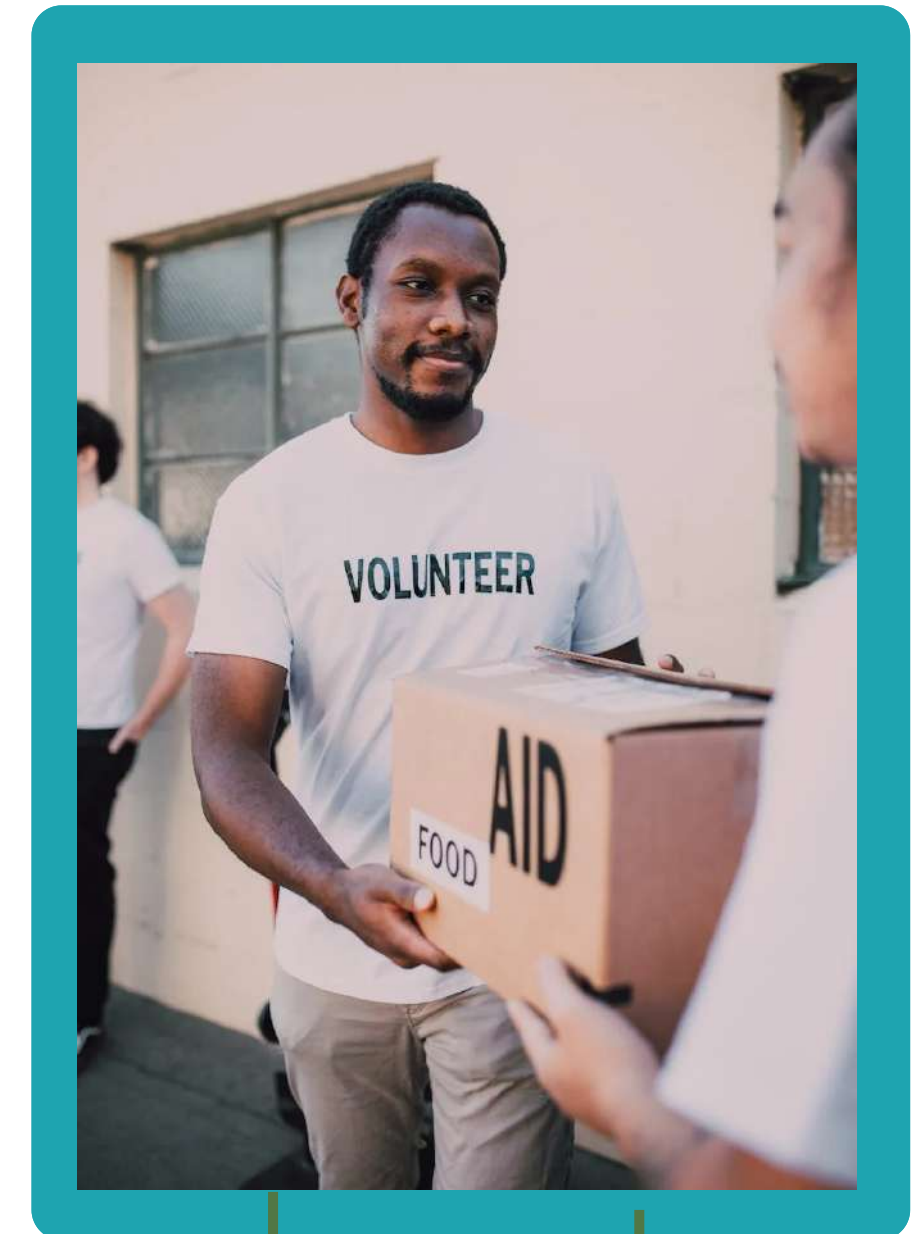

In the fiscal year 2023, NSC demonstrated its dedication by effectively assisting **559** households in attaining housing stability. Furthermore, NSC promptly responded to emergencies by providing temporary emergency housing to **273** individuals and families in need.
